MINO REQUEST – PK2018-02103 Bullet Points: Constituent with question about Pickering Airport Lands

- As part of Rouge National Urban Park (RNUP), Parks Canada now administers approximately 9,700 acres of former Pickering Airport Lands which were transferred by Transport Canada to Parks Canada in two separate land transfers in 2015 and 2017.
- Once lands were transferred, Parks Canada assumed all existing residential, agricultural and commercial leases and utility agreements.
- Parks Canada will transition existing leases to Parks Canada leases, beginning this year. Due to the number of leases, this process is expected to take several years.
- Should there be a vacant property, Parks Canada would assess the condition and suitability of
 the lands and property within the context of future plans for RNUP, including assessing the
 natural, cultural and agricultural heritage of the property and the potential for future trails and
 visitor amenities.
- Parks Canada is currently developing a fair process for selecting potential new tenants should suitable rental vacancies become available in the future. In the future, should vacancies be identified and a tenant selection process confirmed, RNUP would appreciate help with facilitating communication, and may be in contact with the MP office, as appropriate.

How come the government of Canada needs to keep the Pickering Lands under Transport Canada?



Thank you for your e-mail message of February 23 and March 16, 2019, regarding the status of the remaining Pickering Lands and any future development related to a proposed airport.

In 2013 and 2015, Transport Canada transferred a total of 40 square kilometres of land for inclusion in Rouge National Urban Park, representing more than half of the lands committed for the establishment of the park. Since then, the Province of Ontario and the City of Pickering have also transferred lands committed to the park's establishment, while the Toronto and Region Conservation Authority (TRCA) has transferred another portion of the lands committed. Work is still ongoing with the TRCA and the cities of Toronto and Markham to transfer the remainder of the lands committed to Parks Canada for Rouge National Urban Park.

Once completed, the park will be more than 79 square kilometres in size, making it one of the world's largest protected areas in an urban setting—19 times larger than Stanley Park in Vancouver and 23 times larger than Central Park in New York. Should additional land be made available for the park, the *Rouge National Urban Park Act* has a clause to enable enlargement of the park via the addition of lands to the schedule of the Act.

As the matter you raise also falls within the jurisdiction of the Honourable Marc Garneau, Minister of Transport, I have forwarded to him a copy of your correspondence.

Green Durham Association (GDA) is a non-profit, registered charity dedicated to protecting, preserving and enhancing the forests, farmlands and natural areas that lie northeast of Toronto in Uxbridge, north of Pickering and adjacent to Greenbelt lands.

Parks Canada officials have had several constructive and positive discussions with one of GDA's officers, Mr. Brian Buckles, regarding GDA's work on trails and its desire for better regional trail connections with Rouge National Urban Park.

It is Parks Canada's understanding that GDA, a local environmental non-government organization, has been approaching various elected officials to advocate for the transfer of an additional two parcels of land to Parks Canada that are currently under the administration of Transport Canada for a potential future airport.

In a recent meeting with Councillor Pickles from Pickering on March 23, 2017, intended to discuss trail entry points and connections from the Pickering and Durham trail systems, the Councillor raised one item concerning GDA's desire to have additional parcels of land added to the park in two areas: along West Duffins Creek south of the Canadian Pacific Railway Havelock Subdivision and in the northeast of the Park to improve connections with the Claremont community. As these parcels are on the section of Transport Canada land that is not slated to transfer to the Park, Parks Canada officials referred the Councillor to Transport Canada.

During the Standing Committee in the House of Commons, a Member of Parliament raised this issue to Mr. Daniel Watson, Chief Executive Officer of Parks Canada.
