The Government of Canada is taking a balanced approach to the management of the Pickering Lands, ensuring environmental, aviation and economic demands are being met.

- In June 2013, the Government of Canada announced that it would retain a smaller land area for retention for a potential future airport site in the southeast quadrant of the Pickering Lands. The Government concurrently announced that it was transferring approximately 4,700 acres of the Pickering Lands to Parks Canada Agency (PCA) for the creation of the Rouge National Urban Park (RNUP). The transfer was completed in April 2015. Subsequently, on April 1, 2017, an additional 5,200 acres was transferred to PCA to further expand the RNUP. Transport Canada has retained approximately 8,700 acres for a potential future airport.
- In 2015, Dr. Gary Polonsky, the Independent Advisor on the Economic Development of the Pickering Lands, was mandated by the Government to conduct targeted stakeholder consultations on the future development of the Pickering Lands, including a potential future airport. The Advisor's report, as well as Transport Canada's response to his recommendations, are publicly available online.

- In May 2016, Transport Canada awarded a contract to KPMG to undertake a Pickering Lands Aviation Sector Analysis, which will update supply and demand forecasts from the 2011 Needs Assessment Study for aviation traffic, develop options for the type and role of an airport in the regional airport system, and provide an assessment of the economic impact of these options. The analysis is expected to be completed in 2019.
- In 2018, Transport Canada completed an agricultural lease renewal initiative which provided greater certainty to farmers through longer lease tenures. As of April 1, 2018, all agricultural leases were updated to a 10-year lease term. This agricultural lease model has enabled lease holders to make sound business decisions by providing longer tenures and fixed rental rates.

The timing of any decision concerning the development of a potential airport on the Pickering Lands will be influenced by many market and non-market factors beyond the exclusive consideration of passenger capacities at other airports within the Southern Ontario airports system. Such factors may include, but are not limited to: shifting airline business models, regional population growth and evolving demographics, infrastructure needs and investments, as well as the interests and needs of regional stakeholders.

There are no predetermined decisions based on results from the Aviation Sector Analysis, and no decisions or plans been made to develop an airport on the Pickering Lands. Upon completion of the study phase of the report, Transport Canada will use the Aviation Sector Analysis as one of many inputs into the development of a future recommendation for the Pickering Lands. Any decision on the development of the Pickering Lands will be made based on a sound business case and updated data on aviation demand and capacity.

Dear Minister,

I am writing you today concerning the Pickering Airport lands in my provincial riding of Pickering—Uxbridge. This letter is sent with the full support of the City of Pickering, Town of Uxbridge, and all Progressive Conservative MPPs in the Durham Region.

As you are aware, the airport lands were expropriated by the federal government under Prime Minister Trudeau in the 1970's. Since then, unfortunately, thousands of acres of land have sat idly by, reserved by the federal government for use as airport lands. No development has taken place since expropriation. In fact, several thousand acres were used for purposes not originally intended for when expropriated.

For more than 40 years, the people of Pickering—Uxbridge, whether using the land for agricultural, commercial or residential purposes, have had to lease the land from the federal government.

Without a decision from the federal government concerning the fate of the land, agriculture cannot benefit from long-term planning, residences are not being considered, and business cannot flourish. This has had severe negative impacts on development and growth in my riding and the surrounding regions. In fact, Durham Region is witnessing increased pressures on economic stability, including jobs, housing, and infrastructure. These lands are key to unlocking more economic potential for the Region.

In short, for nearly half a century, the people of Pickering—Uxbridge, and its surroundings, have been denied the benefit of full ownership and potential of these lands by the federal government. This has left us in a perpetual state of uncertainty concerning future development.

This is an injustice to the people of Pickering—Uxbridge, and all of Durham Region, that needs to be corrected as a matter of priority.

Now that another Trudeau is responsible for the lands, I am calling on the Prime Minister and the federal government to decide. Either:

- Provide certainty around the development of the lands in the near term, and release the KPMG Lands Aviation Sector Analysis first started in 2016; or
- Return the lands to the people of Pickering—Uxbridge so that the people can truly benefit from them.

The people of Pickering—Uxbridge deserve an answer from their federal representatives concerning the fate of these lands.

Dear Minister Bethlenfalvy,

I am writing to you in response to your letter to the Minister of Transport, the Honourable Marc Garneau, regarding the Pickering Federal Lands.

I was pleased to read about your commitment to ensuring that agriculture on these Lands benefit from long term planning when the federal government makes a decision regarding the future of the lands.

I completely agree, agriculture and business operations on the land cannot thrive on the year to year leases that have become the norm for decades under previous governments. In fact, when Stephen Harper was Prime Minister for almost ten years, farmers were left in limbo year after year, with no certainty about the long term future of the lands they farmed.

With that uncertainty and the need for better long term planning top of mind, Minister Garneau announced the Pickering Agricultural Lease Renewal Strategy. I'm sure you are aware of the details of this historic policy change, but I'm happy to expand on its importance.

This new strategy provided farmers with the option of signing new 10 year leases, instead of on a year to year basis. This change, which took effect April 1, 2018, ensures that farmers on the Pickering Lands can make business decisions with long term certainty, enabling them to potentially install new tile drainage, invest in better equipment or explore other ways to increase their long term profitability.

I also agree with the comment in your letter that "*these lands are key to unlocking more economic potential for the Region.*" You may be familiar with the Land over Landings report: "*Economic Impact of Remaining Pickering Federal Lands if Returned to Permanent Agriculture*" conducted by prominent economists. It demonstrated the economic viability of the Lands if returned to permanent agriculture, and I have been happy to share the findings of this report personally with the Minister of Transport and officials at Transport Canada.

In your letter, you call on the Prime Minister to do one of two things, which I am happy to address. In regards to providing certainty around the development of the Lands in the near term, I would point you to the new 10 year leases and the Pickering Agricultural Lease Renewal Strategy that I mentioned above.

You also call for the release of the KPMG Aviation Sector Analysis. I know that there have been numerous false stories and rumors circulated that the study has been submitted. My understanding is that it is not completed and that while phases one and two have been submitted, the third phase has not. I have recently inquired with the Minister of Transport's office for an update on when the third phase is expected to be submitted.

The purpose of phase one is to update supply and demand forecasts for aviation traffic in Southern Ontario to determine whether a shortfall in aviation capacity is expected in the next 20 years. Phase two develops and evaluates options for the type of airport and its potential role in the Southern Ontario airport system. The third phase will provide an assessment of the revenue-generating potential and economic impact of these options.

Upon completion of all three phases, Transport Canada will use the KPMG Aviation Sector Analysis as part of its considerations and advice to the Minister on the future of the Pickering Lands. The Aviation Sector Analysis is one of many inputs into the development of advice to the Minister.

I remain committed to fighting for the constituents we both have the honour of serving. Thank you for your letter and your engagement on this important issue.

- I am in receipt of your letter dated May 1, 2019 with respect to the Pickering Lands and the Aviation Sector Analysis.
- Thank you for taking the time to convey your views.
- The Government of Canada continues to take a balanced approach in the management of the Pickering Lands, ensuring that economic, environmental and potential aviation demands are met.
- The vast majority of the Pickering Lands are used for agriculture. Transport Canada leases agricultural land that is operationally feasible/efficient for the department to pursue. Currently, there is essentially zero vacancy of arable land.
- Transport Canada has undertaken an agricultural lease renewal strategy that provides more certainty to farmers through longer lease terms. As of April 1, 2018, all agricultural leases were updated to a 10-year lease term. The updated agricultural lease model provides greater stability for leaseholders to make sound business decisions by providing longer tenures and fixed rental rates.
- Transport Canada is committed to an open and transparent process concerning the future development of the Pickering Lands. At this time, no decision has been made on the development of an airport on the Pickering Lands.
- As you may be aware, Transport Canada is currently undertaking an Aviation Sector Analysis to help inform a future decision concerning the Pickering Lands. Any future decision on the development of the Pickering Lands will be made based on a sound business case and updated data on aviation demand and capacity.

The Government of Canada is taking a balanced approach to the management of the Pickering Lands to ensure that economic, environmental and aviation demands are met.

In April 2015, 4,700 acres (1,902 hectares) of the western portion of the Pickering Lands were transferred to the Parks Canada Agency for the creation of the Rouge National Urban Park. In July 2015, a second transfer of 5,200 acres (2,104 hectares) was announced to expand the park. Transport Canada and Parks Canada are working together to expedite this transfer. As a result, approximately 10,000 acres of environmentally sensitive areas of the Pickering Lands will be preserved and protected in perpetuity.

Transport Canada has retained a smaller portion of lands in the southeast quadrant for a potential future airport. At this time, no decisions have been made on the type, role or timing of a potential future airport. Any decision to build an airport on the Pickering Lands will be governed by demand for additional aviation capacity and a solid business case.

A Needs Assessment Study released in 2011 predicted that an additional airport would be needed in the Greater Toronto Area between 2027 and 2037, and confirmed that the Pickering Lands would be an ideal location for a new airport. Transport Canada continues to monitor aviation demand and capacity to inform future decisions.

Concurrently, Transport Canada continues to engage with local stakeholders on the future development of the Pickering Lands. In July 2015, the Government of Canada announced Dr. Gary Polonsky as the Independent Advisor on the Economic Development of the Pickering Lands, with a mandate to conduct targeted stakeholder consultations and provide a summary report that will inform future decision-making on the Pickering Lands.
